The spin-off from this work was a feminist book, *Siostry Malinowskiego, czyli kobiety nowoczesne na początku XX wieku* (2006), concerning several women appearing in the diaries, among them the Polish-British anthropologist Maria Czaplicka. Kubica has just wrote the biography of her: *Maria Czaplicka, płeć, szamanizm, rasa. Biografia antropologiczna* (2015).

- **Mariola Kulon** student of sociology in the Department of Applied Social Sciences of the Silesian University of Technology. She is researching religious minorities in the Balkan countries.
