Bell Justyna is a PhD candidate at Queen's University (School of Sociology, Social Policy and Social Work) in Belfast, Northern Ireland. Her research focuses on the changing experiences of Polish migrants in Northern Ireland, on the development of their personal communities and the means of dealing with aspects of the life in-between the multiple migration contexts.

Czarnecka Barbara is a doctor in Social Science, a lecturer in marketing at the University of Bedfordshire in Luton, UK. Her principal research interests lie in the field of cross-cultural values and communication and how these influence consumer behaviour and marketing communications. Her recent research has focused on female Polish migrants to the UK and their cultural experiences.

Dzięglewski Mariusz is a doctor of Philosophy in Sociology, a lecturer at the Pedagogical University of Cracow, Poland. His research interests focus on post-accession migration and return migration. He has conducted research into the socio-cultural and economic aspects of the recent wave of migration from Poland to Ireland. In his recent publications he has focused on identity construction, the social mobility of young graduated migrants and the barriers placed on the way to their integration in the host country.

Garapich Michał P. is a doctor in anthropology and a Research Fellow at the Centre for Research on Urban Diversity and Migration at the University of Roehampton, specializing in the issues of migration, ethnicity, nationalism, multiculturalism, substance misuse, street culture and the history of migration from Poland. At the moment his work focuses on homelessness, poverty, alcohol addiction and Eastern Europeans' perception of state and civil society institutions in Great Britain. Besides numerous academic articles published in four languages, he has published widely in the Polish media in Poland.

Irek Małgorzata is a doctor in the Social Sciences, currently a Research Associate at the Centre on Migration, Policy and Society, Institute of Social and Cultural Anthropology at the University of Oxford, UK. Over the past twenty-five years she has conducted extensive fieldwork in different areas including Poland, Germany, Spain and UK, researching migration and transformation in Europe, based on which she has developed a new perspective for the studies of informal networks. She has participated in international projects, hosted by inter alia the Carnegie Institute, Harvard University and Viadrina University. Karnat-Napieracz Anna is a doctor of Philosophy in Sociology, a lecturer in sociology at the Pedagogical University of Cracow (Institute of Philosophy and Sociology), Poland. She specializes in contemporary sociological theory. Her academic interests focus on

issues of individual and collective identity in the postmodern era. She is the author of the book *Tożsamość, czyli świadomość redivivus*.

Kawecki Ireneusz is a professor, dean of the Pedagogical Faculty at the Pedagogical University of Cracow, Poland, a lecturer at the Institute of Education Science, a member of the Scottish Educational Research Association. His research interests focus on qualitative methods in education studies, education policy and the sociology of education. He is the author of numerous publications on ethnographic research in education studies. His recent research has focused on the social and emotional situation of 'Euro-orphans'.

Her academic interests focus on education in the context of a changing social, political and economic landscape.
